



**Richmond Hunting Club Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement (“Agreement”)**

In consideration of participating in today’s activity at the Richmond Hunting Club (“RHC”), I (the “Participant”) represent that I understand the nature of the activity and that I am qualified, in good health, and in proper physical condition to participate in such activity. I acknowledge that if I believe any conditions are unsafe, I will immediately discontinue participation in the activity. **I also acknowledge that alcohol consumption is not allowed while participating in the activity but may be consumed once my participation in the activity has ceased for the day and that no outside food or beverages may be brought in under any circumstances.**

I fully understand that this activity involves risks of serious bodily injury, including permanent disabilities, paralysis and death. Which may be caused by my own actions, or inactions, those of others participating in the activity, the conditions in which the activity takes place, or the negligence of the “Released Parties” named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, injuries, harm and damages I incur as a result of my participating in this activity.

I HEREBY COVENANT NOT TO SUE RHC ITS ADMINISTRATORS, OFFICERS, DIRECTORS, SHAREHOLDERS, AGENTS, VOLUNTEERS, OWNERS, EMPLOYEES AND OTHER PARTICIPANTS (EACH CONSIDERED ONE OF THE “RELEASED PARTIES” HEREIN) AND RELEASE THESE RELEASED PARTIES FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES CAUSED BY OR ALLEGED TO BE CAUSED IN WHOLE OR IN MY PART BY THE NEGLIGENCE OF THE RELEASED PARTIES OR OTHERWISE. I FURTHER AGREE THAT IF DESPITE THE TERMS OF THIS AGREEMENT, I OR ANYONE ELSE ON MY BEHALF MAKES A CLAIM AGAINST ANY OF THE RELEASED PARTIES, I WILL INDEMNIFY, SAVE AND HOLD HARMLESS EACH OF THE RELEASED PARTIES FROM ANY LOSS, LIABILITY, DAMAGES, COSTS, (INCLUDING ATTORNEYS’ FEES AND COSTS), WHICH THEY MAY INCUR AS A RESULT OF SUCH CLAIM.
